

How does your favorite restaurant rate?

There are approximately 3,000 restaurants in Multnomah County and about 350 in mid-Multnomah County.

Multnomah County Health Department Environmental Health Specialists conduct unannounced inspections of food service establishments. These inspectors ensure food safety by evaluating food worker habits and practices; where food comes from and how it is stored in the restaurant; how food is prepared and cooked; and cooling, holding and reheating temperatures.

A restaurant must receive a score of 70 to pass the inspection. Re-inspections are not scored. Customers will find a placard on a restaurant's entrance that indicates if the facility passed its last routine health inspection.
